





**REPORT OF STUDENTS GRIEVANCE REDRESSAL COMMITTEE  
REGARDING COMPLAINT MADE BY MR. FRANCIS JOSEPH KADAM  
ABOUT INCORRECT AND ONLY PASSING PRACTICAL MARKS  
GIVEN IN MARKSHEET OF FYBSC AND SYBSC DUE TO NO RECORD  
AVAILABLE.**

A Complaint has been received by Mr. Francis Joseph Kadam, vide University letter dated 20/1/22, that incorrect and only passing practical marks given in marksheet of FYBSc and SYBSc due to no records available. It is pertinent to note that the complainant does not have locus standi to make the complaint for the following reasons :

1. There has been a **delay of thirty years** for filing the complaint by the complainant.  
Rule P. [1(e)] of Procedure and Directives for Functioning Of College Grievance Redressal Cell (CGRC) of the Department of Students' Development, University of Mumbai states that No applications for redressal of grievances shall be entertained, if the CGRC is satisfied that there is gross delay.
2. The complainant states that he was a student of the college in 1991 – 1992.  
The University Grants Commission (Redress of Grievances of Students) Regulations, 2019., rule 3 (o) states that "**Student**" means a person **enrolled**, or seeking admission to be enrolled, in any institution to which these regulations apply.  
As the Complainant is **not currently enrolled** or seeking admission to be enrolled these rules of the Students Grievance are not applicable to him.
3. The Complainant has **not produced** any Xerox copy of the Marksheet of his FYBSc and SYBSc.







