### 2.1.2

1. The University of Mumbai, vide its letter dated 28<sup>th</sup> December 1989, accepted the benefits of Article 30 (1) of the constitution of India in respect of Rizvi College of Arts, Science and Commerce, Bandra, Bombay.
2. Vide letter no. अशस- २००८/११२/(३२)/प्रक्र. ३५९/२००८/का.१ dated 25<sup>th</sup> June 2009, The State Government of Maharashtra recognized Rizvi Education Society as a Religious (Muslim) Minority Educational Institution. The Religious Minority recognition is applicable to all the Educational Institution of the Rizvi Education Society in the state of Maharashtra. The Religious Minority recognition is applicable from the Academic year 2008-09. As per the notification of recognition, it is imperative to follow the conditions and directions of the Government Order of the Minority Department no. अशस -- २००८/प्र.क्र. १३३/२००८/का.१ dated 4<sup>th</sup> July 2008.

As per the government order.

1. 50% of admission in aided institutes
2. 51% of admission in unaided institutes  
Must be given to the eligible candidates of the minority community for which recognition is obtained.
3. As per circular No. Aff/Recog./Admission/(2018-19)/10/of 2018, of the University of Mumbai, the Minority Colleges shall follow the Order given by the Hon'ble High Court in the matter of Saint Xaviers College and Maharashtra Association of Minority Educational Institution v/s University of Mumbai.
4. In St. Xaviers College and Maharashtra Association of Minority Education Institution v/s Union of Mumbai, Write Petition No. 1726 of 2001, an order was passed by the Hon'ble High Court on 12<sup>th</sup> October 2017 that the impugned Circular dated 30/05/2001, to the extent it provides 50% reservation of seats for backward class students for admission to all courses as mentioned in the impugned Circular in Minority Colleges is quashed and set aside."
5. The Supreme Court did not entertain the special leave petition "The State of Maharashtra v/s St. Xavier's College Ors," Special Leave Petition (Civil) Diary No (5). 23287/2018.
6. Thereafter the University of Mumbai ISSUED Circular No. Aff/Recog./Admission/(2018-19)/10/of 2018 dated 30<sup>th</sup> May 2018 which stated that "The process of admission to Minority Colleges must adhere to the ruling given by the Honourable High Court of Mumbai (dated 12-10-2017) in the petition filed by St. Xavier's College, Mumbai and Maharashtra Association of Minority Educational Institutes v/s Mumbai University and the State of Maharashtra.
7. Thereafter University of Mumbai issued a circular no.spl.cell/2018-19/03/2018, dated 5<sup>th</sup> June 2018, that the intake of the students in Minority Colleges, apart from the Management Quota, shall be 50% Minority and 50% open."

The clarification about 15% management quota was also given in the said circular.

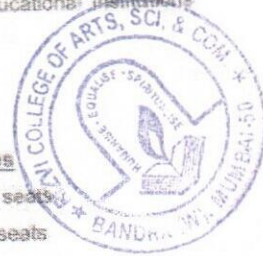
Your attention is also invited to the Circular No. Aff./Recog./Admission/(2018-19)/9/ of 2018 dated 30/5/2018, No. Aff./Recog./Admission/(2018-19)/10/ of 2018 dated 30/5/2018, No. Aff./Recog./Admission/(2018-19)/11/ of 2018 dated 05/5/2018 and No. Aff./Recog./Admission/(2018-19)/12/ of 2018 dated 05/5/2018 regarding pre online registration and admission to various categories including minority.


As per the judgment dated 12<sup>th</sup> October, 2017 by the Hon'ble High Court, Bombay, in Writ Petition 1726 / 2001 in the matter of St. Xavier's College and Maharashtra Association of Minority Education Institutions w/s. Mumbai University and State of Maharashtra, in respect of reservation of seats to the backward class candidates shall not apply for Minority Educational Institutions affiliated to the University of Mumbai

The Distribution of the seats are as under :-



Balance	85 seats
50% Open (First In-house then outsiders, if seats available - only for BA/B.Com/B.Sc)	43 seats
50% reserved (SC/ST/DT/NT/OBC) (First In-house then outsiders if seats available - only for BA/B.Com/B.Sc)	42 seats
